As the outgoing vice president and member of the Disciplinary Committee I would just like to express my deep appreciation to the members of the executive that I have worked with these past four years. By its very nature the D/C is a thankless job obviously no player takes being told they can't play for a game, several games or a year very well but it is our responsibility to ensure that the games are played in a safe environment, and that players are not subjected to verbal abuse or physical threats. This is especially true when it comes to the umpires. We have made it a priority to ensure that the umpires know that we will protect them from any form of abuse and as such have stiffened the penalties to provide security for them. I cannot

stress enough that they are human, only one set of eyes and make mistakes. It's the responsibility of the players and team reps to manage their emotions and act in a sportsmanlike fashion at all times. There is a formal protest protocol that can and should used, as the moment you allow your anger to take control you have lost your right to engage the umpire or other players you, will be ejected from the game and depending on the severity of the offense subjected to multiple game suspensions. We are fortunate that with close to a thousand players only a small fraction have had to have their playing privileges revoked. Finally I would like to thank Mike McMahon and Jeff Martrell for their unwavering support while we served together on the Disciplinary committee.

- Brian Sharples August 19 Executive Meeting Motion move that the league executives deem it mandatory for each team's players to have a uniform that consists of identical shirts or jerseys with unique and individual numbers to be worn in able to play in game. Second by Al Luce .Carried
- 2. Dale Suitor --- August 19 Executive Meeting Motion: I move to change roster cut off date to July 1st instead of June 15.Seconded by Kaus Chandroga. Carried
- 3. Brian Sharples --- October 21 Executive Meeting Motion: Whereas: each year it is becoming more and more difficult to recruit and retain qualified umpires to service our slo-pitch league and Whereas: In order to retain the qualified umpires we do have on the current crew and Whereas: keeping our umpire game rates either close to the middle or above the middle rates throughout the GTA area and Whereas the PMSPL umpire game rates of \$35/game/umpire have been held firm for the past 6 years with no increase Be it Resolved: that umpire rates be increased to \$40/game/umpire effective for the 2016 season. Seconded by Jeff Martell Carried.
- 4. James Unger --- October 21 Executive Meeting Motion: To include a direct link on the league website to team tournament, season and playoff winnings each year. Seconded by Brian Sharples. Carried.
- 5. Wayne MacFarlane October 12 Executive Meeting Motion: To change the courtesy Runner Rule sentence as follows:" The courtesy runner will be" the last player "declared out(F Division Only "any player "), as marked on the score sheet, or the last batter in the batting order should there be no outs in the first inning. Seconded by James Unger. Carried.
 - Motion 1 amended by members who voted in favor to change the word identical to similar. Members voted in favor of Executive motion 1 as amended by members and motions 2 to 5.
